1. Introduction

These Fees, Payments, and Cancellation Supplemental Terms ("Terms") govern all payments, fees, and cancellations related to services booked through Unlimited Gig. By using our platform, you agree to comply with these Terms, which supplement our general Terms of Use.

Platform Fees

Payment Methods

Authorization and Payment Processing

Cancellation by Users

 - Unlimited Gig reserves the right to deactivate or limit a Tasker's account upon:
 - Determination by applicable tax authorities that the Tasker has failed to comply with tax obligations.
 - Failure by the Tasker to provide requested confirmation or documentation of compliance.

6. Disputes and Chargebacks

Users and Providers agree to attempt to resolve disputes directly.

Unlimited Gig may mediate disputes at its discretion but is not obligated to do so. Users initiating chargebacks through their payment provider must provide valid reasons. Unjustified chargebacks may result in account suspension.

7. Changes to Fees and Payment Terms

Unlimited Gig reserves the right to modify fees and payment terms. Changes will be communicated via email or platform notifications. Continued use of the platform constitutes acceptance of the revised terms.
